Farm Business Resilience Plan

Examples of the areas of work to be considered include checking partnership agreements, business contracts with other third parties, registration of land, business contracts, share farming agreements, written tenancy or grazing agreements, possible business restructuring in light of Brexit, succession planning, wills and trusts etc.

Alongside the above, The NFU Legal Board is pleased to announce the extension of its special offer for the Contract Checking Service to 31 December 2022. The offer is a maximum of £1,000 towards the costs of having four contracts checked or drafted by the legal panel firms at £250 each.
